Some background to the below:

- De Mistura met with international Ambassadors and some MPs early today. KE used our guidance. Emphasis was on need to find resolution.
- Large group of MPs, possibly well over 200 but difficult to estimate, met with Karzai. Reportedly some heated exchanges.
- Group was then reduced to 34 MPs (one from each province) plus IEC and ECC plus Supreme Court rep, meeting with Karzai. Latest proposal emerged from that.
- Separately, de Mistura also met with Karzai, showed him the statement that wasn't released and the one that was. No further readout.

They have given the President until 10am Sunday to respond in a public manner. If there is a negative response, they'll convene the Parliament tomorrow afternoon at 4pm.***
