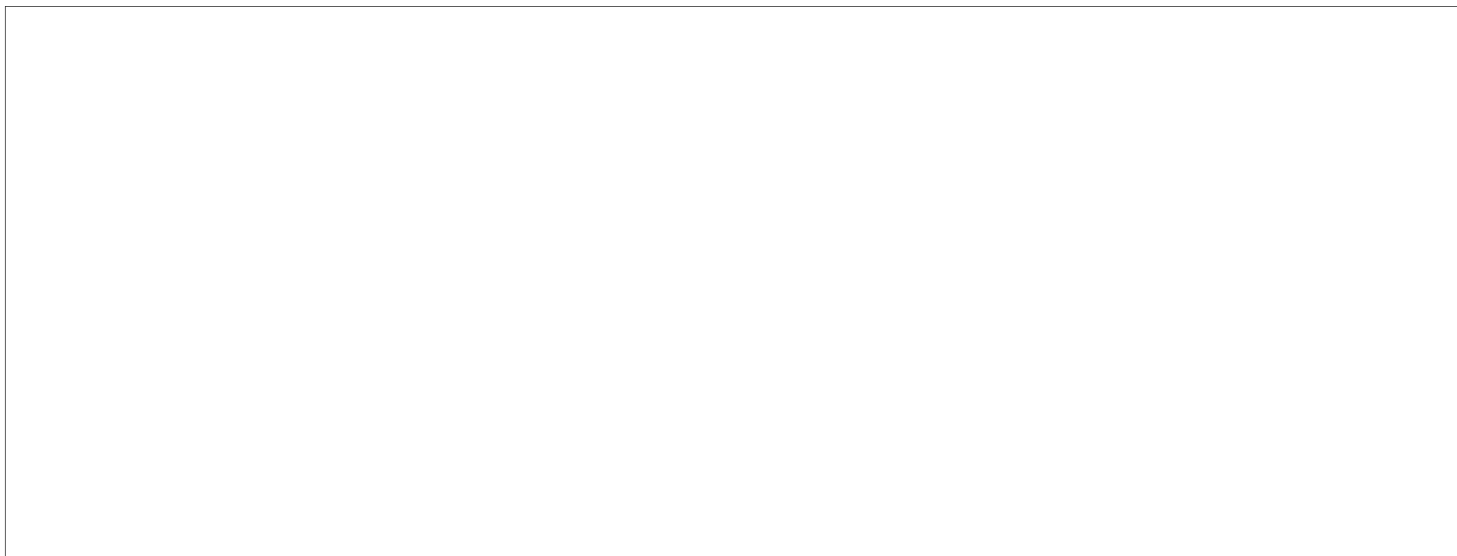

When can we talk today? I would prefer that it be after 5:00 p.m.

Subject of discussion:

[redacted] called me this morning to spell out for me in detail the direction in which he is now willing to go on the elections, his rationale and his timetable for a process that would conclude with a legitimately-elected President and Parliament before mid-May. It does begin with the **cancellation of the Presidential elections of November 28.**

He expressly asked that I contact **you** directly this afternoon to discuss it. He himself will be unavailable most of the afternoon and told me that anytime before early evening for a report of our discussions would be fine.
