For your situational awareness, the Pakistan military requested U.S. military assistance via the Office of Defense Representative-Pakistan (ODRP) at about 1245 EDT today for search and rescue operations to recover its forces trapped in an avalanche that occurred in the Siachen Glacier region of Pakistani-controlled Kashmir on April 6 about 2000 EDT (4/7 about 0500 Pakistan time).

The avalanche occurred at an elevation of about 12,000 feet and buried a headquarters building with more than 100 soldiers, possibly in more than 60 feet of snow.

ODRP passed the request for assistance to CENTCOM and the International Security Assistance Force (ISAF) in Afghanistan, and ISAF has agreed to send a search and rescue team on April 8.

ODRP has also reached out to the Office of Foreign Disaster Assistance (OFDA) for possible assistance.

Sir -- After discussions with IJC and GHQ [REDACTED] the PAKMIL has requested ISAF send forward a Search and Rescue Team (suggested 8 personnel) to Islamabad and we will coordinate their onward movement with the PAK Army. We estimate the team would depart Afghanistan 081200D Apr and be met by ODRP. We will be prepared to house them here at the Embassy if they do not move forward upon arrival.

FYI, PAKMIL will deploy technical Search and Rescue teams that can probe as deep as 30 ft. tomorrow morning. Once we link up our team with the PAKMIL teams we will be better able to define any further requirements.

We discussed other ISR assets that might be available for mapping the area if needed.

We will hold a FONCON with [redacted] at 080900D Apr to review where we are and confirm support being provided. We are working the list of personnel and equipment that would come forward as part of the S&R team to obtain VISA waivers and clearances.

Sir -- FYI, I just received a request from [redacted] to determine if ISAF had any capability to do search and recovery operations in support of the avalanche that occurred earlier today. They have dogs and some limited capability used in the 2005 Earthquake but want to see what else might be available and how long it would take to get it to Pakistan. I am requesting we also determine what is available in the US through the DoS/OFDA channels, as I know there are special civilian teams that the DoS DART uses that could be deployed for such disasters.
