Re: briefing materials, we have helped prepare USDA for this ag ministerial for the past few weeks, including by feeding them briefing materials on various issues (e.g., "right to food," global partnership, biofuels points) and giving them the latest from the President's G-20 announcement. We have also given edits to two Ministerial statements: 1) G8 Ag Ministers statement; and 2) G8 plus Outreach 5 (Brazil, China, India, Mexico, South Africa) ag statement.

Re: attendance, as of now, 11 people (9 substance plus 2 security) from USDA are attending. Our Mission in Rome will cover for the State Department unless you would like to send someone from Washington, in which case we could work with USDA pronto to get on the delegation.
