- Venezuelan aircraft with Zelaya left Miami Center control for Mexican ATC. It did not change its flight plan before it departed Miami Center airspace, so it is still filed for Managua, NIC
- Second Venezuelan aircraft landed in Ft Lauderdale and has not filed another clearance as of this email
- Ecuadorian aircraft (FAE027) with Ecuadorian and Argentine President has departed Miami Center airspace and is under Havana Control on its flight plan to Toncontin, Honduras (Tegucigalpa)
- PFACC has open VTC with JTF-B and is able to pass real-time updates
- 12 - 15K Red (pro Zelaya) peaceful protestors have gained access to the Toncontin airport parking lot and an area unde construction toward the end of the runway.

- NORAD FAA rep reports that both Venezuelan aircraft are now airborne.
- One aircraft was airborne as of 1910Z/1510EDT bound for Managua, Nicaragua. ETA Managua is 2324Z/1924 EDT
- Second Venezuelan aircraft is airborne as of 1924Z/1524 EDT. ETA Ft Lauderdale is 2119Z/1719 EDT
- Ecuadorian flight (FAE027) out of Andrews is still not airborne but is scheduled to take off at 1920Z/1520 EDT. Aircraft has a flight plan to Toncontin, Honduras (Tegucigalpa), 4.5 hours fight time
- Open sources reporting President Zalaya is on flight to Managua

Latest update on Honduras:

- Two Venezuelan aircraft are on ramp at Dulles: One aircraft is scheduled to carry President Zelaya and currently has fight plan to Ft Lauderdale according to NORAD FAA rep
- The second aircraft has a flight plan to San Salvador, El Salvador
- Both aircraft had flight plans to take off at 1426 EDT, and have delayed there takeoff several times and changed flight plans. None of the aircraft have taken off as of this email
- One Ecuadorian aircraft with President Correa on-board was scheduled to take off at 1424 EDT and has also delayed its takeoff several times. This aircraft has a fight plan to Toncontin, Honduras (Tegucigalpa), 4.5 hours fight time
- Demonstrators for both sides (Red Pro-Zelaya) and White (Pro-Interim Gov) are preparing to march to airport at Tegucigalpa from University
