Ambassador,

We just received an email from the Adoption Service Provider about these cases. I am currently reviewing the files to determine if they qualify within the guidelines established recently by USCIS and DOS. Out of the 60 cases, 40 are being adopted by USC. Out of the 40, 5 of the cases were children escorted today and per CNN have just landed in Miami. The remaining 35 we are reviewing now. Some correspondence I've seen says that they plan on bringing the children straight to the airport, and we have responded that they first need to come to the embassy. Once case in particular will be an issue, as it requires the Presidential Waiver. Did you receive the talking points about Presidential Waivers?

The majority of the cases will qualify for Humanitarian Parole.

In the last 30 minutes a number of emails have been coming in about private planes, Ted Turner offering to fly children out, etc.

We have a case coming in tomorrow morning in which the 2 adoptive families are being flown in by CBS helicopter from the DR.

We are preparing as many cases in advance as possible tonight.
