As mentioned on SIPR this morning, we expect the German magazine, "Der Spiegel" to post offensive photos online tomorrow at approximately 1600-1700 hrs EST, relative to Soldiers from 5-2 Stryker Brigade Combat Team (5-2 SBCT) and their 2009 deployment to Afghanistan. Five of these Soldiers were charged with murder for killing Afghan citizens, and are expected to go to trial in the March-May timeframe.

The Department of the Army is the PA lead for this story, and is coordinating their efforts with OSD.

CENTCOM, DOS, and ISAF. Army will respond to the photo release with a statement that is still being approved. If queried, CENTCOM and all others defer media to Army PA. We do not know the exact photos or number that Der Spiegel will publish -- they have revealed that one of the photos is allegedly of a Soldier holding up the decapitated head of an Afghan who he has killed. Der Spiegel is expected to release a hardcopy version of this story in their Monday magazine. **B**5
