Hof stressed the importance of avoiding another veto and noted that in addition to calls for a ceasefire and humanitarian access, a minimally acceptable resolution must also incorporate the four elements of the Nov. 2 AL plan (end of violence, withdrawal of security forces, release of political prisoners, and access for journalists). Hof conveyed Qatar's insistence that any resolution that did not explicitly reference the AL transition plan of Jan. 22 would represent a step backward.

All participants agreed on the importance of coordinating actions, timing, and messaging.
