Bill, Tom, Wendy –

I wanted to provide some context to Jim Miller's note regarding the MIST program, which is a subject I have discussed previously with Bill. As background on MIST, I have attached the 2010 DOD memo which fairly clearly lays out its origins and objectives. MIST (or MISO in the attached note) is the renamed version of what used to be called psyops; the program continues to be run by SOCOM and, although DOD personnel under MIST are offered to posts under COM authority, SOCOM sees this effort as a means of conducting information operations in areas of strategic interest to them.

I am a strong supporter of whole-of-government efforts. EUR has worked hard with DOD to ensure that our policy in Europe overall is reflective of Administration priorities and is fully integrated. And as I made clear to Jim, I am not in a position to comment on the utility or advisability of deploying MIST in other parts of the world; I certainly don't question the value – to take one example from the attached memo – of programs urging civilians to report insurgent activity in Iraq or Afghanistan.
