Tom,

I am in NY today and tomorrow but I felt I should pass this on to you now. My London friend called to tell me he had been contacted by his friend and with an unusual message. First, my London friend was asked to contact both me and our mutual friend separately. To me, he was asked to convey that his friend is concerned that there not be too many cooks now getting involved. He said that he knows that you will soon have a visit from the leader who is next door and he often visits. He understands that this leader wants to help but he is concerned that he not confuse things. New ideas are fine he said, but for the first time, according to my London friend, his friend feels that the only track that has a chance of working is our track and he does not want to be in a position where he is asked to do something that inconsistent with it. He does not want to mislead his next door neighbor but he also does not want to get into things with him either.

With our mutual friend the message was that my London friend's friend would like to know what he and his friend are thinking. He gets indirect messages but feels that those reflect the spin of those who are conveying them and he would like to hear more directly. He would like a meeting with the London

friend and the quiet guy to take place soon—preferably three-way with me there as well or just two-way. My London friend called our mutual friend with that message and was told that he wanted to think about this message and come back to him.

My London friend and I both think we should have a three way meeting just to talk at this point. We are both aware that the environment for our mutual friend probably does not permit more than that at this point. But the fact that the London friend's friend sent this message is both very unusual and the midst of everything else is not a bad sign. In any case, the two of us may get together either next week or more likely the week after in London with the quiet guy to talk and I will push to see if our mutual friend can come as well.

While this may not be the time to resolve fundamental questions, it is also not smart to let things lie because more steps can be taken that will not be good and have a life of their own--and everything can unravel. I have a few ideas but I will pass them on to you directly. Dennis
