Secretario General de la OEA expresa complacencia por anulación de juicios contra ex Presidente Manuel Zelaya

El Secretario General de la Organización de los Estados Americanos (OEA), José Miguel Insulza, expresó su complacencia por la decisión del Tribunal de Apelación de la Corte Suprema de Justicia de Honduras de anular los dos juicios en contra del ex Presidente de ese país, Manuel Zelaya. Consideró que esto pone fin a la situación de incertidumbre en torno a la situación jurídica del ex mandatario que se abrió a partir del golpe de Estado del 28 de junio de 2009.

En vista de las recomendaciones contenidas en el informe de la Comisión de Alto Nivel de la OEA, conformada en junio de 2010 por los Cancilleres del Hemisferio para evaluar la evolución de la situación política en Honduras desde el golpe de Estado, el Secretario señaló que se habría cumplido la principal condición para el retorno de Honduras a la Organización.

Añadió que en forma inmediata iniciará consultas con los Estados miembros para examinar su disposición a convocar a una Asamblea General a fin de considerar este tema
