Thank you Cheryl,

We are very committed to developing and expanding training in this critical cross-cutting area. While we do include gender issues in many of our courses from training for Afghanistan and Iraq to Democracy and Human Rights and our new Diplomacy and Development offerings, we have not yet developed any stand alone training. We have met a number of times with S/GWI staff and Melanne and Anita often present in courses in our Leadership School. What we need now, to move forward on stand-alone offerings (classroom and distance learning) is real course content, specifically case studies and best practices from embassies on a variety of gender issues. Most of all, we need a subject matter expert with the necessary grounding in both theory and practice who has the time to devote to working with us to develop the courses.

For example, we have been able to develop distance learning and classroom training for our QDDR deliverables on Diplomacy and Development because, after a number of fits and starts, we were able to convince AID to detail a senior AID officer, Janet Ballentyne to work nearly full-time on these issues. With Janet's expertise in development and our expertise in course design, we have been able to roll out a great DL course, will offer our first classroom course later this month and Janet speaks regularly to classes all across FSI on development issues.

If we could identify someone with the expertise who could commit the time to work with us we could launch the effort with an interagency policy roundtable at FSI, which could include academics and civil society representatives. That approach has been useful in getting content and speakers for other courses, for example the Religion and Foreign Policy course that we launched last year.

We will also be meeting soon with Carla Capell at USAID, who we are told has developed or contracted for training modules for USAID - bottom line is we really care about this and if S/GWI can identify a partner for us, who has the time and background, we're eager to do more. Cheers, Ruth
