ANGOLA TO RECEIVE \$500 MILLION INVESTMENT FROM RUSSIA

(SBU) Russian state-owned mining company Alrosa will build homes, schools, and dams in addition to partnering with Angola's petroleum company Sonangol on exploration, according to press. The Angola desk notes the investment occurs as Angola attempts to diversify away from Chinese foreign investment.
