The Minister of Information gave a statement a few minutes ago out of the Cabinet Meeting. Key elements from our monitoring:

Egypt is going through a sensitive period. What happened yesterday is an explicitly illegal action. Perpetrators cannot be described as honorable. Perpetrators cannot be described as honorable. The incidents that took place harmed the reputation, image and interests of Egypt.

The meeting agreed on:

- Undertaking all legal measures to refer those who were involved in yesterday's attacks to SS Emergency Court.
- Applying all legal provisions of the emergency law - that was supposed to be lifted- in order to preserve the state.
- Egypt confirms its commitment to international conventions and provisions including securing diplomatic missions in Egypt.
- The government calls upon political forces and media to face the lack of security and refrain from reports that may adversely affect national security in favor of certain arguments.
- Security will undertake legal actions to secure vital buildings, confront thuggery and defend itself.
