No PC has been called yet for Wed 10/20 – though if they do call one during the normal 5 pm slot, that will indeed present a conflict with the Kissinger event. I've will ask for guidance about what we can expect w/Donilon now in charge...both in terms of PCs and whether he intends to continue the small group meetings with you and Gates. [redacted]

Will check about Adm Mullen's dinner and if it is on Thurs 10/21, whether you can make it back in time.

Re the possibility of Raul Yzaguirre on Tues 10/26 – Sharon Hardy with Ceremonials relayed to Raul that we wanted to offer any date other than 10/21 that worked well for him. He came back with Mon 10/25...even though the Franklin Room is booked that evening. President WJC's schedule does have him coming back from Jamaica to DC on 10/26 – but that may be just because they were trying to match up RONS with you. Let me 1) double check w/WJC's office about where he'll be on 10/26 and 2) determine whether Tues 10/26 is an option for Raul Yzaguirre and/or the Council of La Raza folks
