As you know from the news, there is a great deal of concern for the cuts that Bloomberg has proposed. We are trying our best to find a way to save our program which has taken a great deal of energy.

I also want you to know that I keep you in my prayers each and every day. You are doing such a remarkable job and you are truly a "peacemaker" as Jesus describes for our world.
