- Memo on Reconstruction Opportunity Zones: Lew/Verma following up on Reconstruction Opportunity zones for Pakistan and proposed memo on this matter;

- Michael Savage: PJ will follow-up with recommendation on whether to advise his attorney of our efforts; there has been no response from UK to date;

- Pakistan Helos: Lew proposed that we consider sending a pre-notification request on helos for Pakistan to Hill indicating we want the authorization to be done on 1206 or PCCF, whichever is first and by doing so, we will have complied with notification requirements; Verma following up on concept to determine how and if we should move forward;

- IDPS – Lew is moving forward with \$200M as benchmark amount – wants to hear if anyone disagrees (none in room);

- DPRK: P-5 working on resolution; inspection on high seas anticipated to be sticking point for China with Russia hiding behind them on this issue; trial of two journalists expected this week – in past it went trial, fine, release – not sure if it will but that is hope; discussion re: media accounts of new activity for launching missile
