## Helicopter support for Emb Baghdad

- Pat Kennedy noted that Blackwater's contract ends Sept. 4, but problems have arisen with the successor being ready to assume helo support tasks; they have not secured the necessary helos nor obtained the required certificates of airworthiness and are in breach of their contract. Rather than shut down Embassy operations after Sept. 4, it may be necessary to give Blackwater a short (perhaps 2 months) extension until the successor is ready to perform. M is talking to Chris Hill about our options; he would need to discuss this with the Iraqis if Blackwater is extended.

## Libya

- Rich Verma noted the planned demonstration in Englewood, New Jersey this weekend in opposition to Qaddafi's desire to stay there during UNGA. There is now a possibility that Qaddafi will stay at a hotel in Manhattan. Bill will talk to Jeff Feltman and hopes this will be resolved today; if so, H said they would inform Rep. Rothman and Senator Lautenberg.

## Hearings

- Rich reported that Chris Hill is scheduled to appear before the SFRC on Sept 9 and the HFAC on Sept 10, perhaps with Gen. Odierno, although Odierno may not be available those dates.

PJ Crowley noted European press reporting of comments by former UK FS Jack Straw that the British had not provided assurances to us in the 90's that the convicted Lockerbie bomber would serve out his full sentence in Scotland.
