Dan, I'm delighted, as, I'm sure, is the family, that HRC will both attend and speak. Chris, before he died, asked that A.B. Culvahouse (the senior partner of Chris's law firm) and I also give eulogies.

I'm attaching the current draft of what I plan to say. I'm happy to amend it to accommodate what HRC wants to say. I'll send you a copy of A.B.'s draft eulogy when I get it.

I'm sure it would be fitting and moving if she were to reflect a bit on her own interaction with him in connection with issues she worked on during the first term—just to take two examples: the women's summit in Beijing and her trip to South Asia. Also, I think she'd be the ideal person to make that point that she and President Clinton relied on Chris for advice on a whole range of issues, far exceeding the bounds of foreign policy—including personnel issues, going back to the selection of Gore as running mate and the transition process in which she and he were so much involved in Little Rock.

I'm adding Madeleine Albright to this e-mail, since she'll be accompanying the Secretary to LA and, of course, worked closely with Chris herself. Let me know if there's more that I can do.
