Posts, please confirm a control officer ASAP and forward their contact details to McDuffy, Parks, Lowenstein, and Heyworth.

Posts, please note that country clearance requirements do NOT/NOT apply to CODELs and STAFFDELS, and most Legislative Branch travelers do not use the eCC system. H/EX will cable formal notification and fiscal data for the visit, but such notification should not be treated as a CCR. Cables from the field, moreover, should not refer to country clearance in the subject line or elsewhere. Please see 2010 ALDAC 54822.

Post, please note that only Members and Congressional staff should receive per diem chargeable to the fund cite. Military escorts and other participants will settle their own hotel bills.

Post, please prepare a cost estimate for all anticipated expenses for Congressional Committee approval before the CODEL departs the U.S.
