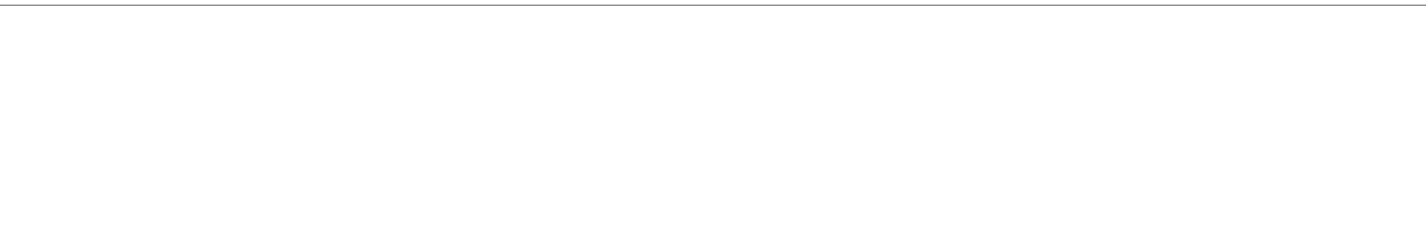

**Subject:** Update on the Electoral Process

1. On June 20, the official journal, Le Moniteur, published 13 Chamber of Deputies and 2 Senate results from the 19 races left over from the March 20 second round. President Martelly will decide whether to hold another second round or adopt the OAS report once a new government takes office. The 2 Senators are likely to be seated in time to consider Rouzier's nomination, as Prime Minister; however, it's unlikely the 13 Deputies will be seated timely to consider Rouzier's nomination; and

2. According to CEP Vice-President Jean Theleve Pierre-Toussaint, the CEP will publish the definitive results of the May 29 partial elections on June 20.

Bottom line: there remain 4 lower house seats still to be decided to complete the 2010-2011 elections.
