This is the first African team to qualify for the Little League World Series ... and State denies them visas.

STATE COLLEGE, Pa. (AP) — The U.S. State Department has denied visas to enter the United States for a youth baseball team from Uganda that qualified for the Little League World Series.

Officials at Little League headquarters in South Williamsport said Friday that the State Department did not give a reason for the decision other than that documentation provided by the team "contained discrepancies."

The Rev. John Foundation Little League team from Kampala would have become the first squad from the continent of Africa to compete in the World Series, which starts next month.

Little League president Stephen Keener said in a statement the organization would take a few days to decide how to proceed. The Uganda team had won the Middle East and Africa region tournament.
